MINUTES: It was moved by Joe Hillwig and seconded by Jenny Switzer to accept the minutes from the previous meeting as presented. Motion carried.

<u>CITIZENS TO SPEAK: Philip Ahn</u>. Mr. Ahn live in the Low Rise Apt 3. He received a very high water/sewer bill. His previous bill had no usage. Joe said to make a work order for a new meter and to bill him for 3,000 gallons per quarter. Susan will make adjustments to bill and notify him of the new balance due.

<u>Steve Boyle</u>. Mr. Boyle had attended a previous meeting and said that he had replaced his sewer line. He said his excavator put a one call in to have the lines marked and that Dean did not mark them correctly. This resulted in more digging than necessary. He asked for compensation, but did not give a figure. He will have to provide an itemized bill to council.

<u>Dewaine and Michelle Gillott.</u> Mr. & Mrs. Gillott want to build a garage on vacant land that they own on Robinson St. They need a bit more room than the setbacks allow. They have obtained a variance from the Snow Family on one side. Beth Kaufman on the other side will not give him the variance. It would be a 1 foot area where the eve of the roof would overhang. Council said they believe that it is only the building that matters, but that they would check with the solicitor.

<u>Joy and Lucas McCluskey.</u> Lucas would like to demolish the house he owns at 705 Robinson St. that is vacant and build a garage there.
